RE: Notice of Exercise of Holdover Provision for the Early Intervention Contract

Dear Rhonda Roth:

You are hereby notified that in accordance with provision BB in the General Provisions section of contract routing number 17 IHIA 89195 between the State of Colorado, Department of Human Services, Office of Early Childhood, and Eastern Colorado Services for the Developmentally Disabled, Inc. the state hereby exercises the holdover provision for a period not to exceed two months, effective July 1, 2020, at the same cost/price specified on page 1 of the original contract, not to exceed \$85,590*.

*An appropriation for Early Intervention Direct Services General Accounting Encumbrance (GAE) is hereby added to this contract. The maximum amount payable for GAE is subject to appropriated funds, not to exceed \$2,500,000, which is split among other Early Intervention (EI) vendors. See Exhibit I, Section 11. Early Intervention Direct Services General Accounting Encumbrance (GAE).

BB. Holdover: In the event that the State desires to continue the services provided for in this Contract and a replacement contract has not been fully executed by the expiration date of the Contract, this Contract may be extended unilaterally by the State for a period of up to two (2) months upon written notice to the Contractor under the same terms and conditions of the original Contract including, but not limited to, prices, rates, and service delivery requirements. However, this extension terminates when the replacement contract becomes effective when signed by the State Controller or an authorized delegate.





